## Privacy

The JM Burgerscentrum (hence referred to as JMBC) fully complies with the requirements of the Dutch Personal Data Protection Act (Wet Bescherming Persoonsgegevens). All personal information provided by visitors to the JMBC's website is treated with the utmost care, and is carefully processed and protected. In doing so, the JMBC makes every effort to take personal preferences into account. The JMBC has implemented a number of security measures, including measures to prevent unauthorized parties from accessing personal information.

## Technical information collected

The JMBC also collects technical visitor information, such as information about the hardware and software used by visitors and information about their actual visit to the site. This information is not linked to individuals and cannot be used to trace the identity of a visitor. The data collected is used to provide statistics for the assessment of the effectiveness and effects of the information provided on the site and the navigation structure. This enables The JMBC to optimize the website, thereby further improving its service provision.

## Cookies

To provide more services to website visitors, most websites use cookies. Cookies are a useful technology to collect and use information. As a result websites become easy in use. Cookies for instance enable you to be logged in on a website permanently or that your preferences such as location and language settings are remembered.

By using cookies, website holders can see how often their websites - and which pages - are visited by their visitors.

Cookies are stored on your computer and you can remove them whenever you want. This is done easily. Click on one of the browsers below to directly go to the manual of your browser. Please do realize that after removing cookies, some websites want you to set up your preferences again or ask you to login again.

If you do not want websites to store cookies on your computer you can adjust your browser settings so you will get a warning before cookies are stored. You can also adjust the settings in such a manner that your browser rejects all cookies, or reject the cookies of third parties. You can also remove cookies that have already been stored on your computer. Please note that you must adjust the settings separately for each browser and each computer that you use.

Please be aware that if you do not want cookies at all, we can no longer guarantee that our website functions properly. It may be that some functions of the website will be lost or even that you are no longer able to view certain websites.

## Use of cookies by the JMBC

The JMBC uses cookies as well. We would like to inform you about the various types of cookies that are stored on your computer when you visit one of our websites.

### Functional Cookies

Functional cookies are used to offer you, as a website visitor, the correct functionality and user experience. Functional cookies will store your preferences for your language and login status. Functional cookies are always stored since they are essential for the proper functioning of our websites. Not giving permission to store cookies has no consequences for functional cookies.

### Analytical Cookies

To determine which parts of the website are most interesting for our visitors we continuously try to measure with third party software how many people visit our website and which page is visited most. For this purpose we use cookies. Statistics are made of the information that we collect in this manner. These statistics give us insight into the number of website visits, which page is visited most and how much time is spent on the various pages, etcetera. As a consequence we are able to make the structure, navigation and contents of the website as user-friendly as possible. The statistics and other reports are not traced back to persons.

The JMBC concluded a processor's agreement with Google regarding Google Analytics. In this agreement it is laid down that Google only acts as processor in the processing of the personal details of website visitors.

We use a Google Analytics cookie for:

- Keeping count of the number of visitors on our web pages
- Keeping count of the times that every visitor spends on our web pages
- Determining the sequence in which someone visits the various pages of our website
- Assessing which parts of our website requires adjustment
- Optimizing the website

### SharpSpring cookie
